



## The 2018 Great Whio Adventure Terms and Conditions

- 1) The promoter of 'The 2018 Great Whio Adventure' Competition ("**Promotion**") is Genesis Energy Limited ("**Genesis Energy**").
- 2) The Promotion is open from Friday 9 March 2018 to Friday 27 April 2018 at 5pm.
- 3) The Promotion is open to New Zealand residents only.
- 4) Entry is limited to one entry per person.
- 5) Entries must be received by Genesis Energy by 5pm on Friday 27 April 2018 and late entries will not be accepted.
- 6) The Promotion prize ("**Prize**") is as follows:
  - i) Return flights for up to two adults and two children from the closest (NZ) national airport to the winner to a destination near to a whio habitat in either the North or South Island (as chosen by the Department of Conservation). Flights may be taken at times when convenient to the Winner but must be within the Prize Redemption Period. The winner (and his/her accompanying travellers) is responsible for his or her own transport from their residence to and from the nearest domestic New Zealand airport for the flights;
  - ii) Five-day car hire with Hertz Car rental, with car pick up from the local airport. [Standard Hertz Ts&Cs apply.](#)
  - iii) Four nights' accommodation for 2 adults and 2 children
  - iv) One day out with Genesis Energy and the Department of Conservation ("**Ranger Family Experience**");
  - v) A Prezzy card to the value of \$800. [Standard Prezzy Card Ts&Cs apply.](#)
  - vi) A hard copy of the Whio Education resource to be provided if the winner is a child attending primary school.
- 7) The winner will be determined by Genesis Energy who shall for this purpose be deemed the judge.
- 8) The Prize will be awarded on Friday 11 May 2018. Genesis Energy will make all reasonable attempts to contact the winner of the Prize ("**Winner**"), by phone and/or email in accordance with the details supplied. If a Winner is unable to be contacted by Friday 18 May 2018, Genesis Energy will draw another Winner for the Prize.
- 9) The prize must be used between Monday 14 January 2019 and Friday 1 February 2019 (except for the Prezzy card) ("**Prize Redemption Period**")
- 10) If the Winners are unable to travel during the Prize Redemption Period, the Winner will need to contact Genesis Energy and, subject to availability, Genesis Energy may be able to arrange for the Prize to be used at an alternative time agreeable to the Department of Conservation. If Genesis Energy and the Winner cannot come to a mutually agreeable date for the Prize to be taken, the Winner may have to forfeit the Prize at Genesis Energy's discretion, in which case Genesis Energy will choose another Winner.
- 11) The Winner will be responsible for expenses including, but not limited to, spending money, meals, drinks, activities, travel insurance, incidentals and all other ancillary costs associated with redeeming the Prize. The Winner must obtain travel insurance to protect themselves against additional costs incurred in the event of unforeseen circumstances.
- 12) Subject to any applicable law which cannot be excluded, Genesis Energy, its employees and agents shall not be liable for any loss, damage or injury suffered or sustained (including but not limited to direct or consequent loss or loss arising from negligence) arising directly or indirectly out of or in connection with the Promotion or any part of the Prize.
